- **Description of the packaging:** Transport packaging for PE pipes (one-way pallet, PE stretch film, PP strapping, PE end caps)
- **Type / model:** Packaging system for PE pipe ring bundles on one-way pallet

- **Description of the packaging:** Ring bundles on a one-way wooden pallet (solid wood), fixed by full wrapping with PE stretch film (polyethylene). Secured by PP strapping made of polypropylene, protected and closed with PE pipe end caps.
